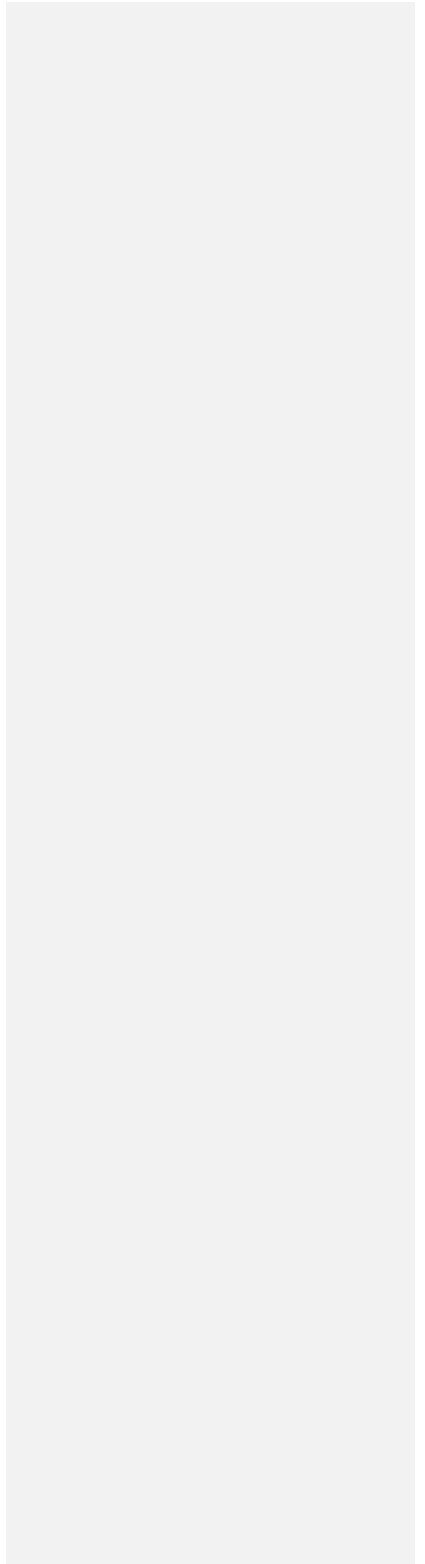

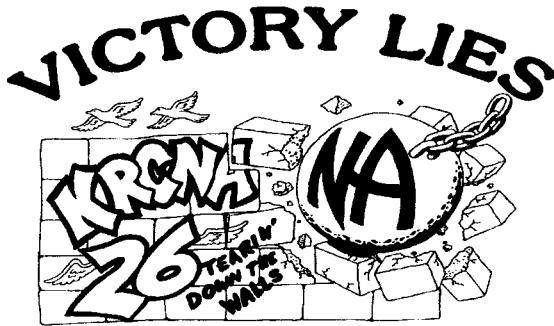

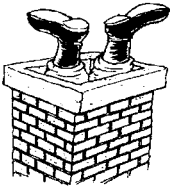

Dear ASC,

Owensboro Area passed the KRCNA 27 convention and Across the Rivers has accepted. I nominated Jim D as the KRCNA 27 chair. Since this was a position that was to be seated in November, a motion was made to close nominations with unanimous approval. The call to vote was asked for and voted unanimously and the vote for Jim D was conducted unanimously.

The Unity ad hoc committee was disbanded by the Chair since it has lasted much longer than the original six month time line laid out in Regional Policy and no new business has been occurring. The Pennyrile Area made a motion to create a new ad hoc committee whose sole purpose is to look at the feasibility of combining our Region and the Bluegrass Region. I will get the exact verbiage for the next Area meeting.

The Vice Chair Mike from Bowling Green and the RD JR from Bowling Green have missed previous two Regions and were sent a letter of concern. Mike showed up and stated that he could not fulfill his position because of personal obligations and resigned. JR did not show up so a vote to impeach was called and passed unanimously.

This was Bobbies last month as Chair and Bobby was thanked for his commitment. The following positions are now open at region: Chair, Vice-Chair, RD, H&I, Pt, Literature and P&P.

There was discussion as to why the RDA position does not automatically advance to RD position. There was discussion and the P&P was discussed as to a sentence that reads: In the event of a vacancy in either of these positions, regular voting procedures will be followed. A motion was made to change the policy to allow for the automatic moving up for the RDA to RD in the event of an opening in RD position. I will get the exact verbiage for the next Area meeting.

## SECRETARY'S REPORT


Dear Trusted Servants,
