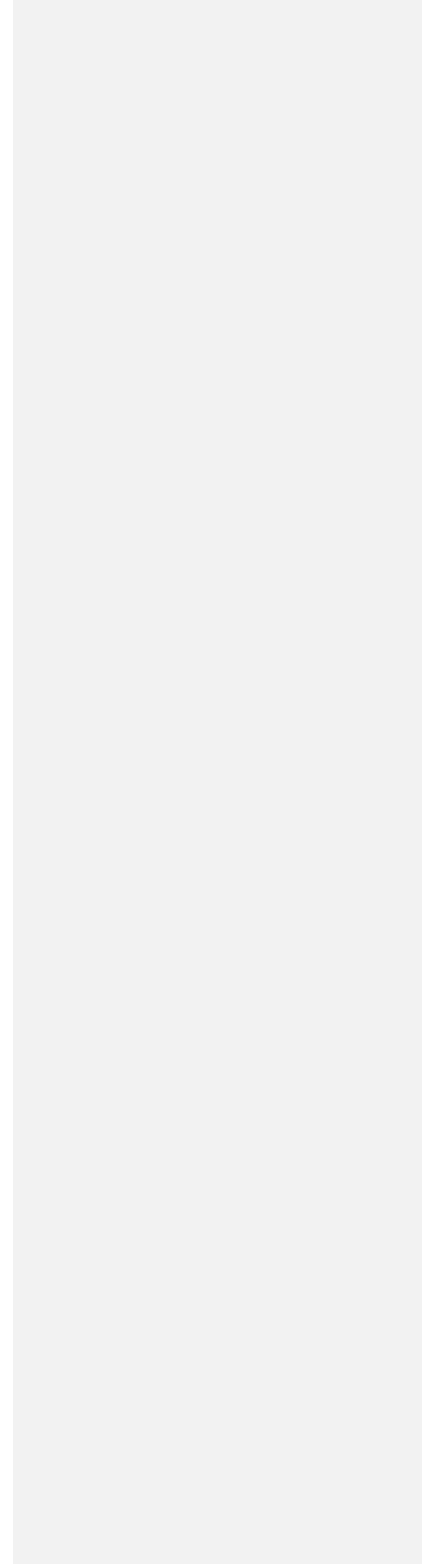

The ad hoc subcommittee, created to “explore the possibility of having an AREA Convention in 2013 to celebrate the AREA’s 30<sup>th</sup> birthday” met for the 3<sup>rd</sup> and final time on July 31<sup>st</sup> at Rebus. Andy S. opened the meeting at around 1:30pm with the Serenity Prayer. We then read the Service prayer and the 12 Traditions.

Andy and Dave H. visited with Robin Hall at the Clarion hotel on Wednesday to discuss having a convention there. She said that Clarion could provide us with a Grand Ballroom, (500 seat capacity) Pavilion, (500 seat capacity) and 4 terrace rooms (60 seat capacity each) for \$1800 (not including taxes and fees) for a weekend starting at 3pm on Friday and ending on noon on Sunday. Dave, myself and the subcommittee all agreed this is a very good deal. She also gave us a special room rate of \$69 a night, which we also all agreed was an exceptional rate. We feel the lower room rate will attract more “Evansvillians” to stay at the convention. I have brought a contract to represent what Clarion is willing to provide for us.

After review of the potential and the effort required this committee believes that to have a hotel convention for our 30<sup>th</sup> anniversary as an area is a do able event. We understand that it will tax the resources of our local fellowship, not only financial but also our greatest resource, people. We believe that financially to put on this convention, the committee created would need to raise somewhere around \$4,000 in seed money to provide for necessary upfront expenses. We also believe that other income generated from the sale of pre-convention items, merchandise and registrations any additional funds to go into the convention weekend with great potential of at least breaking even, exist. There is an enthusiasm locally from many for this endeavor and it would be necessary for those members to step up and get involved.

During the work of this subcommittee a discussion took place on this area becoming a 501c3 non profit organization. We do believe that in the near future this should be a consideration and a discussion held by the area. We may even want to consider becoming a LLC. But of course this would be the work of another committee.

If the groups were to approve moving forward with this activity we believe the following items need to occur. Currently we have no ASC policy for holding a convention. We propose adopting and modifying the current regional convention policy since writing and voting on new policy would be a time consuming endeavor. We would also propose opening nominations for a Convention Chair from the floor today and accepting nominations from the groups in September and voting on this position in October. Currently regional guidelines for this position require the Convention Chair to be someone who has previously held a position on a convention committee and has at least five years clean. This body could change those requirements as it deems necessary.

We as a committee believe that the decision to move forward on this activity rest with the groups and should be voted on by them. We think that since time is of the essence in moving forward with planning and fundraising that today in new business a preliminary motion to move forward should be made. If approved we believe that we should proceed with the following three items today in new business.

1. Make a formal motion to go back to the groups to host a 30<sup>th</sup> birthday convention in the summer of 2013.
2. Make a motion to adopt and modify current regional convention guidelines as necessary.
3. Open nominations for a Convention Chairperson.

This would begin the process and all these motions could be voted on in at the October ASC. If the first one fails then it would be unnecessary to proceed however we would suggest that all groups vote on all three motions no matter how they vote on the first one since we would be voting on the balance if the first one passed by those present. In this manner we would protect the right of the groups to have the final say in this decision. We also believe that with the complexity involved we should have all these motions pass with a 2/3rds majority. We would also like to add that any work completed by this committee would be made available to a convention committee if we have one and they desired to have it.

Conventions are a celebration of recovery. Planning for one is hard work but even the planning can be very rewarding as well. We, as a subcommittee, feel that having an Area Birthday Convention in July/August of 2013 would be an incredible way to celebrate our recovery!

This completes the work of this Ad-Hoc committee and it is now disbanded.
