- Dee B. – Turkey Day brought in \$360.89 that she turned over to the Treasurer today. Motion made to write a check for these funds to Activities for funding the Christmas Marathon. Motion seconded, passed.
- Mandy A. – As part of her report, the \$325 seed money for the KRCNA fundraiser was turned over to the Treasurer today. Motion made to write Activities a check for \$325 seed money to fund the New Year's Eve function. Motion seconded, passed.
- Area storage \$35 plus \$20 for two committee meetings approved, \$55 total to 1043 Fulton.
- No Regional donation this month, as checking account balance (minus Regional PR funds) is less than \$250.
